

ELKO - Rates for many services at Elko General Hospital will increase an average of 4.9 percent. Hospital administrator Bill

Welch said that along with adoption of the 1986-87 fiscal year budget and the long-range plan, trustees approved the rate increase that goes into effect July 1. The hospital budget for

1986-87 totals slightly less than \$7 million and includes a four percent cost-of-living increase for hospital employees.

Welch noted that some hospital departments, such as emergency room and surgery, will have no rate increase at all, while others will have increases up to percent. The overall 6 increase will be 4.9 percent, he explained.

### **Carson City** giri, 6, drowns **In Walker**

A 6-year-old Carson City girl drowned Saturday afternoon in the fast-running Walker River between Yerington and Smith Valley, a Lyon County Sheriff's Department dispatcher said.

The girl, whose name is being withheld pending notification of her father, was attempting to cross the river near the Wilson Canyon Bridge when the 3 p.m. accident occurred, Lyon County dispatcher Joanne Sanford said.

The girl's mother told investigators she tried to stop her daughter from entering the river, but the daughter kept trying to cross. The mother tried to grab the girl but was unable to keep her grip due to the fast current, Sanford said.

The girl's body was found at 5:10 p.m. about six miles down river from where the accident occurred. She was pronounced dead at the scene.

The Lyon County Sheriff's Department was assisted in its rescue attempt by the Yerington Police Department, the Yerington Volunteer Fire Department and the Smith Valley Volunteer Fire Department.
