Justice Stevens said, "we have recognized, however, that in order to remedy the effects of prior discrimination, it may be necessary to take race into As part of account. eradicating racial discrimination, innocent persons may be called upon to bear some of the burden of the remedy."

Jusitce O'Connor stated that the Court forged a degree of unanimity; "'it is agreed that a plan need not be limited to the remedying of specific instances of identified discrimination for it to be deemed sufficiently tailored to the correction of prior discrimination." This is a rejection of the Reagan Administration's position that only identifiable victims are beneficiaries of affirmative action remedies. Justice Marshall stated

"the Court is at least in accord in believing that a public employer, consistent with the Constitution, may The Greater Evergreen undertake an affirmative action program which is designed to further a legitimate remedial purpose and which implements that purpose by means that do not impose disproportionate harm on the interests, or unnecessarily trammel, the rights of innocent individuals directly and adversely affected by a plan's racial preference.

Terry Eastland, a Justice Department attorney, said 'it's a good decision that furthers the objective of non-discrimination for all of our citizens." When asked by telephone about the effect the decision will have on the Justice Department's opposition to Executive Order 11246, which requires goals and timetables in the awarding of government contracts, Eastland said, 'the decision calls into question whole regulatory enforcement order." He said that the Justice Department won its case and that was all the Court was asked to decide. The Court's decision and various arguments have no effect on their views of Executive Order 11246.

Althea Simmons, NAACP lobbyist, said "the decision underscores the constitutionality of the use of
