## World-Ranked Middleweight Nunn Spinks--Holmes Faces Boston Friday decision

Undefeated and now world-ranked middleweight Michael Nunn meets Charlie Boston, until two months ago rated No. 5 in the world, in a 10-round main event on the monthly ESPN professional boxing card Friday, July 25, at the Showboat Hotel, Casino, Country Club and Bowling Center.

Nunn, from North Hollywood, Calif., and Boston, from Trenton, N.J., are two more talented youngsters, and whoever wins at the Showboat stands a very real chance of gaining contender consideration in the suddenly competitive middleweight division.

The card, promoted by Bob Arum's Top Rank, Inc., of Las Vegas and New York in association with the Showboat, starts later than usual this month - at 7:30 p.m. Doors to the Showboat Sports Pavilion open at 6:30.

Tickets, priced at \$10 for general admission and \$15 for ringside reserved, are on sale from 9 a.m. to 5 p.m. Monday through Saturday at the Showboat Sports Pavilion Ticket Office.

Also on the card assembled by Mel Greb will be a semi-main event Vegas matching Las featherweight Jeff Franklin against slugger Lupe Gutierrez. Four other bouts complete the card.

Indoor Track & Field Meet

Nunn, ranked No. 9 by the World Boxing Association, has a record of 16-0 with 11 knockouts while Boston, ranked No. 5 by the WBA in May, has a record of 12-2 with six knockouts. Both are southpaws.

Boston, 24, gained world prominence on Jan. 31 of this year when he took a 10round decision over contender Dwight Davison, then ranked No. 2 by the WBA. That boosted Boston to No. 5 in the WBA, a position he held until he was decisioned by Doug DeWitt on May 6. Both bouts were in Atlantic City.

The semi-main matches Franklin, with a record of 11-1-1 and four knockouts, against Gutierrez, from San Jose, Calif., with a mark of 11-1 and nine knockouts.

This is the first big test for the 23-year-old Franklin in his relatively short but extremely promising career. He's won all four fights this year, two by knockout, including his most recent outing on July 13 at the Showboat when he stopped Donnie Porter in the third.

## IBF holds fast to Former NFL Great

NEW YORK- Larry Holmes' appeal to overturn his split decision lost to Michael Spinks in their International Boxing Federation title rematch was denied by the IBF, it was revealed Tuesday.

Holmes lost the title to Spinks on a close, but unanimous decision Sept. 21, 1985. He failed to regain the title April 20 at Las Vegas, Nev., when judges Frank Brunette of New Jersey and Jerry Roth of Nevada voted for Spinks.

Brunette scored it 144-141 and Roth 144-142. Judge Joe Cortez of New York favored Holmes 144-141.

Several ringsiders felt Holmes had won.

"The boxing experts and unofficial judges can very easily make decisions, James Stevenson of Bogalusa, La., president of the IBF's Grievance and Appeals Committee, wrote to Charles Spaziani, Holmes' attorney, denying the appeal. "However, the one that

counts is the one rendered by the 'official' judges assigned to work the fight.
