#### D.A.'s Operation Clean Sweep Cracks Down

ney Bob Miller announced the successful today completion of a program code-named Operation Clean out of the 111 bench Sweep designed to crackdown on absent parents in non-compliance with their child support obligations.

"Operation Clean Sweep" is a strong, clear message to Clark County that my office won't tolerate the continued victimization of children and their custodial parents by those responsible through court order to provide them with support," stated Miller.

Operation Clean Sweep consisted of two-man teams federal monies. of investigators from the District Attorney's Office added Miller, "that this is serving bench warrants on non-complying absent sweeps aimed at these parents in Las Vegas, North
