400 candidates fail to submit forms of Ethics Commission

CARSON CITY - The state Ethics Commission has turned over to the attorney general's office the names of 400 candidates for elected office who have not filed their financial disclosure forms with the commission.

Lee-Ann Keever, assistant to the commission, said roughly 1,000 candidates had to comply with the law mandating the filing of onepage financial disclosure forms by July 14.

Those who have not complied with the law may face prosecution. Nevada state law says that "willful failure to file a statement of financial disclosure' is a misdemeanor, punishable by a maximum penalty of six months in jail and a \$1,000 fine.

form asks The candidates for elected office to disclose sources of income that make up more than 10 percent of total household income. In addition, property ownership other than the candidate's personal residence, and debts exceeding \$5,000 must be reported.
