He receives referrals from various Social Service departments recommending public guardianship for adult wards over the age of sixty (60), and services required on cases with insufficient

resources for private burial.

Stevenson said he does not feel that prejudice will play a

role in the campaign or the District Three seat on the Washoe County Commission.

''Although Republican,'' said Stevenson, "I've got a lot of friends who are Democrats. In fact, some of my best friends are Democrats.

Stevenson acknowledges that he will be a long-shot in the District Three race.

"I'm a political novice. I'm up against an incumbent. I don't have his bank account. But, I do have his record as a county commissioner to run on, said Stevenson.

"I'm not sure the voters of District Three know who Gene McDowell is after four years as a commissioner."
