organization monitoring South African and Carribean concerns said, "South Africa is a nation in disintegration," and a "society on the verge of explosion."

The press conference occurred at the wake of election year maneuvers and a South African sanction tugof-war with Senate liberals caught in the crossfire. Harsh economic measures passed by the House and favored by Senate Democrats, have consistently failed in the Senate. Alan Cranston (D-Cali.) proposed sanction legislation similiar to Rep. Ronald Dellum (D-Cali.) sweeping House Bill that calls for a near total trade embargo with South Africa and requires all American firms to leave within months. Six Cranston's attempts to strengthen Foreign Relations Committee Chairman Sen. Richard G. Lagar's (R-Ind.) limited sanctions bill were unsuccessful. Senate Majority Leader Robert J. Dole (R-Kan.) and other Republican Senate leadership have tried to link the South African issues with government aid to the Nicaraguan contras.

Robinson called Dole's position 'inexcusable.'

"People are dying (in South Africa) on a daily basis," he said. "We are not prepared to trade one crisis for another."

Gray said attempts to join South African issues and contra aid were ''inappropriate'' and accused the Senate of holding sanction legislation hostage.

"Their real motive is to delay, slow-walk and avoid a vote before August 15," he said

Black leaders and political officials fear a harsh sanctions bill would not receive the two-thirds vote needed for passage by the Senate in the likelihood that President Reagan vetoes the bill.

Also attending the press conference were Coretta Scott King, of the Martin Luther King, Jr. Center for Social Change, NAACP board chairman William Gibson, National Urban League vice-president Douglas Glasgow, and Rep. Walter Fauntroy (D-D.C.). Mary Frances Berry of the Civil Rights Commission, Reps. Ronald Dellums (D-Calif.) and Mickey Leland (D-Tex.) were

The economic malaise gripping this nation affects an increasingly wider spectrum of Americans, from the displaced white steelworker in Pennsylvania, to the dispossessed farmer in lowa, to the laid off Black auto worker in Detroit.
