The Aministration label affirmative action implementation as "reverse discrimination' and 'preferential treatment' for Blacks.

In June of this year the Supreme Court, while deciding the Jackson, Michigan teachers' case, ruled that the Affirmative action plan in this case violated the Constitution's equal protection under the law. The decision upheld the legality of affirmative action programs.

Analyzing the Jackson decision, Representative Augustus Hawkins, Chairman of the House Education and Labor Committee, stated makes it clear that the use of a race-based affirmative action programs narrowly tailored to address the effects of pase discrimination are constitutional. The case, "the Court once again

decision said that affirmative action remedies are not solely limited to identified victims of discrimination, but are available to every member of the class being discriminated against. The Court endorsed the use of statistics in establishing a method to combat discrimination, and the concept of goals and timetables to advance minority hiring was declared legal. The Supreme Court decision is a clear rebuttal to the anti-civil rights positions Reagan advanced by Administration officials Brad Reynolds, Clarence Thomas and Clarence Pendleton.

In July, the Supreme Court handed down the ruling in International Association of Firefighters vs. City of Cleveland and Sheet Metal Workers' International Association vs. EEOC. The Lawyers' Committee on Civil Rights, which filed an amicus brief in both cases, states that in the Firefighters

upheld the priniciple that employers are free to engage in voluntary, race-conscious affirmative action plans as long as such plans are reasonable and meet the standards laid down in the Weber case. Brad Reynolds stated at the beginning of his appointment that disagreed with the Weber decision and that he hoped it would be overturned. In the Sheet Metal Workers' case, the Lawyers' Committee "the Court made it clear that the federal courts have the authority to order race-conscious relief over the objection of a defendant. where a violation of Title VII has been shown and the race-conscious relief is necessary, as a practical matter to provide a full remedy. The Justice Department departed from bipartisan consensus in 1982, under the leadership William Bradford The EEOC Reynolds. from departed that consensus after the 1984 election and has even

that it will not enforce them.'

The Lawyers' Committee noted that there has been a slackening in enforcement of fair employment laws by both this Justice Department and EEOC' scarce resources have been wasted in trying to reopen consent decrees in 51 cities in order to eliminate the affirmative action provisions which the Nixon, Ford and Carter Administrations had obtained

John Wilson, public affairs representative of the Civil Rights Division of the Justice Department, said "Brad Revnolds doesn't see much change in the Court's decision from what he was doing. He views the decisions, as he does busing, as being one tool for remedying discrimination. Reynolds considers recruitment as employment mandate of the '64 Civil Rights Act, but he is against the requirement of hiring Blacks and women--as is required by affirmative action. Ralph Neas of the Leadership Conference said that the decisions 'underscore bipartisan commitment to affirmative action. The Court repudiated the Administration's position on affirmative action.

Barry Goldstein of the NAACP Legal Defense Fund said, "Now that we've won and the Administration has lost, we're where we were six years ago. We now know that affirmative action is permissible, and that it will continue to provide jobs for Blacks and women.

Benjamin Hooks Executive Director of the NAACP, hailed the decisions as "a great victory for the civil rights movement and a significant rebuke to the Reagan Administration's pernicious efforts to destroy affirmative action.

Bill McEwen, spokesman for the National Association of Manufacturers, said, "we utilizing been have affirmative action plans for over 20 years. We were brought into it kicking and We were screaming, but over the 20 years, we've learned that there's a reservoir of talent out there, of minorities and women, that we hadn't been cusing before. The byproduct of affirmative action is that it makes us treat all \*people better. We've found that it works.''
