

Top Las Vegas Amateur Boxers Face Los Angeles Saturday, Sept. 27, at Showboat

A team of top amateur boxers from Las Vegas, including Akeem Ainfowski and John Turnstall, meet a squad from Los Angeles in dual match competition Saturday, Sept. 27, at the Showboat Hotel, Casino, Country Club and Bowling Center.

This will be the first amateur action here since March and the third of five scheduled dual matches this year for the Las Vegas team under the direction of Golden Gloves of Nevada president and tournament director Hal Miller.

The card, which includes 15 to 18 bouts in the open, Junior Olympic and novice divisions, starts at 2 p.m. Doors to the Showboat Sports Pavilion open at 1. Tickets, priced at \$5 for adults and \$2.50 for those 14 years of age and under, are on sale from 9 a.m. to 5 p.m. Monday through Friday at the Showboat Sports Pavilion Ticket Office.

Pacing the Las Vegas team will be 119-pound Ainfowski, who represented his native country of Nigeria in the World Amateur Championships in Reno in May, and 165-pound Turnstall, current Nevada Golden Glove and ABF champion.

Also on the Las Vegas open division squad are Damian Farina at 106 pounds, Gilbert Diaz at 112, Mevia Catarino at 125, Tony Prezzato at 132, Von Sop Lee and Michael Gonzalez at 139, Michael Fuzazzi and Tracy Gonzalez at 147, Wally Sanchez at 156, and David Hashbrouk at 165, and David Beasley and Pedro Matera at 178.

A Sketch of Mike Tyson

Seldom has a fighter burst upon the boxing scene in the manner of Mike Tyson. This soft-spoken young man with the explosive fists has, in just 20½ months, moved from prospect to a title shot against World Boxing Council heavyweight champion

Trevor Berbick on Nov. 22 at the Las Vegas Hilton.

The 20-year-old from New York, now living in Catskill, N.Y., has the chance to fulfill his goal of becoming the youngest heavyweight champion, beating the mark held by Floyd Patterson who

in 1956 captured the title at age 21, five weeks short of his 22nd birthday.

Ironically, both Patterson and Tyson were trained by the late Cus D'Amato. He shaped the powerful but raw Tyson and helped make him the devastating and most

feared puncher in the sport today. Despite being a pro less than two years, Tyson's body attack already is legendary. And he has the numbers to prove it.

He has a record of 27-0 with 25 knockouts, and 15 bouts have ended in the first

round. At 5-11 ¾ and with a 71 inch reach, Tyson may not be the largest heavyweight of all time, but his 220 pounds are solid muscle. That translates into superb slugging ability.

Out of the ring Tyson enjoys raising pigeons.
