Assembly race results contested

Wendell P. Williams, who is slated to face incumbent Gene Collins in November for a seat in the state Assembly. faces a challenge today from Rev. Marion Bennett, the man he vanquished in the Democratic primary by 20 votes

Bennett will appear before District Judge Joseph Pavilkowski today to argue that ballots cast in three precincts should be thrown

In a formal "statement of contest" to Williams' 853victory, 833 Bennett contends that because Madison Sixth Grade Center did not open on time and because Election Department officials made errors in marking ballots, precincts' ballots should be thrown out.

Even if those precincts were eliminated from the election, Williams would still win by 16 votes, according to Election Department figures. In the three contested precincts. Williams defeated Bennett by only four votes, 368-364, not enough to change the outcome.

The Assembly District 6 race which encompasses much of the city's Westside. is expected to be one of the tight contests that determine whether the Republicans retain a 27-15 edge in the Legislature's lower house.

Collins, a former Democrat who became a Republican them to be traced to the after the 1985 legislative session, is considered vulnerable because of his party switch.

Clark County Registrar of Voters George Ullom said he believes the official primary election protest is virtually unprecedented in county history. Ullom said Bennett also could have demanded a recount, but that he did not do so before the deadline. which is five days after the election.

Ullom would not comment on Bennett's allegations until the case is resolved.

200 black miners disrupt memorial service for miners

About 200 black miners. shouting union slogans and tribal chants, on Monday disrupted a companysponsored memorial service for 177 men killed in a mine fire last week

"We're not going to pray with whites today. We've never been allowed to pray with whites. We'll have our own rites." miners shouted.

Holding clubs and stell rods over their heads, they ran through the outdoor service 10 times, drowning out sermons by white and black preachers. Hundreds of other workers who came for the service poured out of bleachers and chairs to join the dissidents.

After the service, they continued to race around a field near the No. 2 shaft of Kinross gold mine until officials from the National Mineworkers Union of calmed them down.

A fire in the shaft last Tuesday killed 172 black and 5 white miners, and injured 235, mostly blacks.

Regional union organizer Tshidiso Mothupi said the union would hold its own memorial Wednesday at nearby Secunda.

In Johannesburg, the United Democratic Front, the South Africa's main multiracial anti-apartheid alliance, said in a statement it joined trade unions in holding the mine owners "fully responsible for this tragic loss of 177 precious lives, lives that have made possible the millions in

riches that the mining bosses have today.

In Pretoria, President P.W Botha said foreign government and mining industries were welcome to their send representatives to South African mines to check the safety standards.

Botha said in a message to the International Confederation of Free Trade See MINERS, Page 7
