ask the principal or dean to remove the error, and explain why. If the school official refuses, request a hearing. Put your request in writing and send it to the principal or other school official who is designated to handle this issue.

"What does a hearing involve?" - In this case, a "hearing" means a meeting between you and school officials, presided over by an impartial observer known as a hearing officer. The purpose is to allow you to present evidence about the school record that you dispute. You must be given a hearing within a reasonable amount of time. You can bring another person with you to support your case, such as a lawyer (at your expense). If the hearing's decision is against you, you may still insert a written objection to the false material into your child's school records

'What can I do if the school refuses to let me see or correct my child's records?" -- Immediately send a written complaint to FERPA office, U.S. Department of Education, 400 Maryland Avenue, S.W. Washington, D.C. 20202. The Education Department investigate will your complaint, and then will notify both you and the school of its decision. If the **Education Department finds** the school in violation, it will order the school to correct the violation.
