A Black Publishers Roundtable on "The Role of the Black Press in the Political and Economic Empowerment of Black America" was also convened by Rep. Gus Savage (D-Chicago), along with a session on "Blacks and the Business of Sports, featuring testimony by major athletes. The workshops were among about 25 sessions set for the Rayburn House Office Building with most other forums and activity arranged at the Washington Hilton Hotel headquarters.

The District of Columbia Republican Council scholarship dinner featured Connie Mack Higgins as chairman and Robert Brown as guest speaker. Brown was former Richard Nixon presidential assistant and recent proposed nominee as ambassador to South Africa. Singer Nancy Wilson was scheduled guest soloist at both the Republican affair and the CBCF dinner gala, the following night.

## Defensive Driving Course Offered

The Nevada Occupational Safety and Health Act requires the adoption of safety and health programs by local governments. Clark County has been conducting a Defensive Driving Course for all employee who drive county vehicles.

On October 22, at 6 P.M. in the Commission Chambers, 225 Bridger Avenue, on a one-time only basis, all employees and interested citizens may enroll in this Defensive Driving Course at no charge. At this session, a student may apply to have up to three traffic demerit points removed from his record.

This course is designed to reduce accidents and turn out safer drivers. As a part of the 4-hour Driver Improvement Program, participants learn lessons on the cost of driving, accident prevention, and driving under the influence of alcohol.
