## NEVADANS THROWING AWAY MILLIONS!

The state of Nevada is the **only state** in the Union forfeiting millions of dollars every year to the Internal Revenue Service!

**Every other state in the nation claims its fair share (up to 16%) of the federal taxes paid by estates to the Internal Revenue Service.**

Every state but Nevada.

Why? Because every state but Nevada has a provision in its laws to allow for the "pick up" of up to 16% of all taxes paid by states to the federal government.

Why? Because Nevada voters approved a state constitutional amendment in 1942 which banned an inheritance tax in Nevada. The effect has been that Nevada also is denying itself its fair share of federal estate taxes — **death taxes people pay no matter what state they call home.**

**We can't change the fact that the federal government taxes large estates. (Only 5% of all estates are subject to the federal estate tax.) But we can insure that part of that money stays in Nevada by passing Question 5.**

**Question 5 DOES NOT CREATE AN ADDITIONAL TAX.** In fact, it SPECIFICALLY FORBIDS A STATE ESTATE TAX!

**Passage of Question 5 will bring an estimated \$5,000,000 to \$10,000,000 back to Nevada every year. The money is earmarked for education, to be divided between public schools and the University of Nevada System.**

Keep Nevada's hard-earned dollars in Nevada.

## WE SUPPORT QUESTION 5 — *The UN-Tax*

Question 5, *The UN-Tax*, calls for approval to pick up Nevada's fair share of the federal estate tax, which is already imposed by the federal government. The funds are specifically earmarked for education, to be divided between public schools and the University of Nevada System.
