Recently, as has happened so many times before, Dorothy Height had a terrific

Dr. Height is the president of the National Council of Negro Women, a 50-year-old organization founded by Dr. Mary McLeod Bethune that has always helped our community tap into its own strength. Her idea was to bring us together in Washington, D.C. for a "Black Family Reunion," a bring public celebration of the enduring strengths and values of the black family.

the organization's own expectations. On September 13-14, an estimated 200,000 blacks of all ages--fathers, mothers, teenagers, grandparents, and toddlers-gathered on the mall in downtown Washington for the event. Under blue skies, and within sight of the Capitol and other national monuments, black families strolled and picnicked on barbecued chicken, baked beans, and corn muffins.

We celebrated children, their creativity and sense of fun. In one large tent, youngsters could learn arts and crafts, such as how to make flowers or ice cream. Children watched children do tap dancing, cheerleading or "double dutch'' jump rope.
This ''Reunion'' did not

seek to sweep our family's problems under the rug, Instead, it gave us hope and showed us ways we can cope with them. In one tent. members of a teen theatre group "rapped" to other teens about the problems of teen pregnancy and the importance of being 1

responsible about sex and of communicating with their parents. A special unit provided warnings about the dangers of drugs.

Like any reunion, this one brought together diverse segments of the black community: public officials, church leaders, artists, educators, and families of all kinds, rich and poor. It included two-parent families, single-parent families and extended families.

As Dr. Height has said: The result exceeded even "amidst a background of significant negative projection of the black family today, there is truly a need to take stock of the whole picture--the unwritten history of the black family, its strengths, and coping skills." The Black Family Reunion helped remind all of us--and our nation--of that heritage. It was very timely idea. And it was fun.
