Nevada has set the date of Wednesday Dec. 3 at 2:00 p.m. as the date to hold a public hearing on whether or not the council will approve recommendation that Highland Blvd. be changed to the name of Martin Luther King Blvd. Dr. King was born and raised in Atlanta. Georgia, educated Morehouse College at and Boston University School of theology with a Ph.d degree. He was a Baptist preacher of the Gospel as well as civil rights fighter and a world hero among the have nots. Dr. King also was a winner of the Nobel Peace Prize in Oslo, Norway and co-pastor of Dexter Avenue Baptist Church in Atlanta, Georgia. Shortly after leaving school, Dr. King was elected as the leader of the Montegomery Bus Boycott, when Mrs Rose Parks was refused a seat on the front of the bus.

A year later the bus company agreed to intergrate after the U.S. Supreme court had ruled that discrimination was unconstitutional. This action was the beginning of the socalled civil rights movement in America. It caught on like a sage brush fire and spread over the entire country. used with sound. In this case, the listener hears only a soft melody. The name of the product is played along with the melody but at too low a level for your conscious mind to detect. Nevertheless, in both of the above cases, the name of the product was undetectable. In other words, you are not aware of the presence of what is taking place. In subliminal suggestion, if you are aware of it. It does not enter your subconscious mind but remains in your conscious mind where you can decide to buy or not buy the product. With subliminal suggestion, no such deliberation takes place.

Fortunately for the public the Federal Communications Commission outlawed the use of subliminal advertising 15 years ago because of its powerful manipulative effect. Nevertheless, there are other sophisticated and effective methods to coax you into buying a specific item.

Simple suggestion tends to spur impluse buying. picture of an attractively prepared product being consumed or otherwise used by an equally attractive individual appeals to the need of the consumer to be as attractive as the actor or actress who is using the product. The mind tells the customer, subconsciously, that he/she will be made

used subliminal suggestion beautiful by the product or, to brainwash people into in the case of food, will delectible delicacy. You, thus, automatically reach for it. It is virtually impossible to view the same commercial over and over again without being affected by it.

When you are standing in the checkout line you are exposed to magazines and displays of snacks and a variety of candies. It is difficult to resist temptation to toss several of these items into your shopping cart. As you observe them, you are made to imagine yourself enjoying them. The next time you go to the supermarket, notice how many snack items clutter your path to the cashier

Winnie Mandela Slated To Speak

BALTIMORE-South African anti-apartheid activist Winnie Mandela has agreed to speak in January at the Johns Hopkins Medical Institutions during an annual tribute to Martin Luther King Jr.

It is uncertain whether Mandela, whose husband, Nelson, is the leader of the outlawed African National Congress, will be able to attend the event. activities are restricted by South African the government, which has not let her leave.

But Levi Watkins Jr., a Hopkins cardiologist who has organized a commemoration of King's birthday for the last five years, said he is working with the U.S. and South African governments to get a passport and visa for her.

Watkins helped arrange the visit of South African Bishop Desmond Tutu, an anti-apartheid activist and Nobel Peace Prize laureate. to speak at the tribute last
