## Only the Ridiculously Rich Win With Reagan Your Taxes are Going up

Readers of this column will recall the first regime of Reagan's aim was to reduce low income laborers Black and white, as well as, other minorities to serfs. Having half accomplished this economic ignominy in America during his first term office, the Charlie McCarthy puppet of the conservative faction of the Republican party has put into effect his greatest shame on the supposedly middle-class of America. True they voted for him and deserve what they just got with Ronald Reagan requested new tax. bill.
