Blacks Nationwide Learn Their Role In Making A Better America

Recently, more than six thousand Black people descended on Washington the sixteenth Congressional Black Caucus (CBC) weekend. They were from all across the country -from various walks of life and different economic categories.

The Caucus theme was "Black America: Generations in Transition." For three days, forty-seven workshops were conducted on subjects that have special relevance to Blacks. At these workshops, panels of experts presented information which was followed by a dialogue between the audience and the panel members.

Since the life span of Blacks is shorter than Whites, several workshops were conducted on various

phases of health as they Black the concerned community. These included diseases in which Blacks are highly susceptible--drugs, cancer, heart trouble, health hazards peculiar to the Black community, homicide, AIDS myths and the realities of its the Black impact on community, infant mortality and high blood pressure. In these workshops, strategies for survival were offered.

The Thursday morning plenary session was televised for America's Black Forum. The CBC members were questioned by Georgia State Senator Julian Bond, the Forum moderator. members talked about major issues confronting Black America. While all Caucus members participate in all issues, each is assigned to

take the lead in specific fields, so Mr. Bond questioned them about his or her special category. At the conclusion of the members' presentation there participation by audience. It was revealed that CBC has sponsored 300 pieces of legislation during the present 99th Congress.

Representative Collins, the only Black female member of Congress, held a workshop on discrimination in the braodcast media and discrimination in advertising in minority media. It was emphasized that suffer from the Blacks unfairness of businesses advertising policies

Mrs. Collins conducted a workshop on the Future of Black Women In Politics. This report revealed that in the spring of 1986, there were 146 Black women elected as state judges, mayors legislators.

Pepsi-Cola Company Receives Majority Firm Of The Year Award

Emergency Energy Funds Available Family Support

Governor Richard Bryan announced today that the Energy Crisis Intervention Program, administered by the state, will provide up to \$200 for eligible households with an energy related

emergency.
Energy Intervention Program (ECIP) will help pay utility bills to avoid termination of service, minor repairs on furnaces or heaters, stove pipes, chimneys, broken windows or fuel lines.

The ECIP, which begins January 1, is for emergency situations only. Qualified applicants can get immediate aid from local agencies, such as county welfare offices, the Salvation Army or senior centers. Local agencies in each of Nevada's 17 counties have received federally funded grants from the state Office of Community Services.

In order to qualify for ECIP. you must have a total household income for the previous month, which falls at our below 150% of the established For instance, a guideline. one person household, must be at or below \$670, while a four person household must be at or below \$1375.

Nevada also has a second energy assistance program, the Low Income Home Energy Assistance Program, which began November 1. This program is designed to help low income Nevadans with the purchase of fuel for winter heating. It isn't designed for emergency situations.

Division Relocated

The Family Support Division of the Clark County District Attorney's Office has just completed the relocation of its offices into the Clark County Courthouse Building at 200 South Third Street, Room 545.

The Family Division is responsible for providing child enforcement and paternity establishment services to the citizens of Clark County. These services are free of charge to all families participating in the Aid to Families with Dependent Children program. A nominal fee of \$2.00 is required for other individuals requesting assistance.

"It's important that the people of Clark County know that these services exist, stated Attorney Bob Miller, "and where they can go to find them.
