We former slaves now have some portions of freedom and are much better off than we were before. This in and of itself gives us something to celebrate and rejoice about. Although, as Black people in America, we do not yet have full social, political and economic freedom, we still have much to be jubilant about. There is much relevance for a Jubilee observance in 1987, which is less than fourteen years before the end of this century. This great concept of release, freedom or emancipation has been appreciated by Blacks since the historical signing of the Emancipation Proclamation by Abraham Lincoln, January 1, 1863. The first crucial victory for the North in the battle against the South was the Battle of Antietam. This was the victory the North needed before Lincoln would announce on Sept. 22, 1862 that if the South did not return to the Union by Jan. 1, 1863, he would declare their slaves to be forever free.

National Council for Policy Review Resolves to Support Black Beauty Industry and Approves Resolution on Japanese Issue

The NCPR resolution calls on the National Business League to: conduct a national advocacy and awareness campaign through its local affiliates and chapter National Trade Association network; advocate and support the "Proud Lady' logo campaign of the American Health and Beauty Aids Institute (AHBAI) on a national basis; and issue a formal statement in support of Black businesses that participate in the Black beauty industry and denoune the racially-oriented statements made by Mr. Bottner.

Lafayette Jones, executive director of the American Health and Beauty Aids Institute (AHBAI), addressed the NCPR meeting during the National Business League's 86th Annual Convention recently held in Cleveland, Ohio. He informed NCPR members that the Black beauty industry is a Billion dollar market, of which 50%
