# **1987 CIVIL RIGHTS BILLS ON 'FAST TRACK'IN CONGRESS**

Washington, D.C. - An all out drive to revive the endangered, controversial, anti-discrimination and equal housing laws in Congress started this week after 39 to 53. U.S. Senators introduced bi-partisan legislation in the Capitol.

Both bills calling for a Civil Rights Restoration Act and Fair Housing Law "were on a fast track in the Senate and House'' (of Representatives), indicating early passage of the measures according to Ralph G. Neas, executive director of the Leadership Conference on Civil Rights, which is rallying support for the legislation.

The LCCR is a coalition of 185 labor, religious, civil rights, social welfare, educational and community groups organized during the height of "The Movement" against racist, jim-crow, segregation laws 30 years ago. Recently, the coalition has been strengthened by the addition of women's groups, senior citizens, ethnics and the disabled.

The coalition was founded by Arnold Aronson, veteran Jewish leader: the late A. Philip Randolph, pioneer black leader who organized the Brotherhood of Sleeping and Roy Car Porters, Wilkins, late NAACP president. Rev. Benjamin Hooks, current NAACP president, is present LCCR chairman.

Civil Rights The Restoration Act, which failed passage last year in the con-

servative 99th Congress, was introduced this year by Sen. Ted Kennedy (D-Mass) in the new Democrat dominated Senate. He was joined by nine party colleagues and two Republican sponsors, along with 42 co-sponsors in the 100 member Senate.

In the House of Representatives, the chairman of the Labor and Human Resources and the Judiciary Committees are the principal sponsors. These include Reps. Augustus Hawkins (D-Calif.) and James Jeffords (R-Vt.), and Peter Rodino (D-NJ), Don Edwards (D-Calif.) and Hamilton Fish, Jr. (R-NY), Over 200 members of Congress are expected to cosponsor the bill.

The Fair Housing bill was introduced by Sen. Joseph Biden (D-Del.), Paul Simon (D-III.), and Arlen Spector (R-Pa.). Biden is chairman of the influential Senate Judiciary Committee. The strong new measure was sponsored in the House by Congressman Rodino. chairman of the Judiciary Committee, and Edwards and Fish. "These two measures are priorities," declared Neas.

Because of the U.S. Supreme Court decision in the Grove City (Calif.) case in 1983, the government may now subsidize discrimination, said Neas. The court ruled that funds could only be prohibited in specific acts. The bipartisan Civil Rights Restoration Act would prohibit Federal funding by reviving four statutes barring such actions against all persons because of race, sex, disability or age.

However, passage of the proposed new laws are threatened again by several amendments exempting religious organizations and persons "who choose to have an abortion." The LC-CR "vigorously opposes these amendments...which would gut'' the effectiveness of the legislation, said Neas.

Fair Housing legislation has passed several times in the House of Representatives since 1977, but failed in the Republican controlled Senate under the leadership of Sen. Strom Thurmond (R-S.C.). It is expected to pass now with the help of the new bipartisan coalition and the support of the Leadership Conference on Civil Rights which is growing stronger.
