### **Administration Proposal to Transfer** Minority Business Development To **Small Business Administration Assailed**

The Minority Business Enterprise Legal Defense and Education Fund, Inc. of Washington, D.C. announced a major resolution urging Congress to defeat President Reagan's 1988 budget proposal transferring the Minority Business Development Agency to the Small Business Administration.

Parren J. Mitchell, the Fund's founder and chairman, said the Reagan Administration's transfer proposal will have "a negative affect that will prove devastating to the minority business community and the economic progress of this nation.

Mitchell, former Congressman and Chairman of the House Small Business Committee, said the special resolution urges Congress to defeat the transfer proposal and to pass legislation strengthening NBDA, which is presently located within the U.S. Department of Commerce.

Mitchell said the fact that NBDA is located within a Cabinet-level federal department such as the Commerce Department is critical to the continued federal effort to assist the creation and expansion of healthy minority businesses

Reagan ministration's specific proposal is to transfer MBDA from the Commerce Department to SBA effective October 1, 1987. An estimated 140 of MBDA's 240 employees would be transferred, along with the agency's largest progrm - the Minority Business Development Centers Program. The remaining 100 employees
