#### Psychiatric exam ordered

Suzanne Chilow to determine if she is competent to stand trial on an attempted murder charge after allegedly trying to shoot a murder defendant in a Reno courtroom.

Washoe District Judge Peter Breen delayed Chilow's scheduled plea Tuesday and ordered the examination. He called for psychiatrists to report back to court May 28. They will determine if she understands the charges against her and can assist her attorney, Herb Santos, in her defense.

Chilow, 38, of Sparks is charged with attempted

Psychiatrists will examine murder and possession of a concealed weapon for pulling a gun in court April 2 and aiming it at Eileen Cunningham, who was being arraigned with two co-defendants on charges of murdering unemployed waitress Kathleen Kennedy, Chilow's friend. The pistol's safety was on and no shots were fired.
