Issued on New Year's Day in 1863, the proclamation freed only slaves in the secessionist southern states, excepting West Virginia and parts of Virginia and 386-6374 or 384-3884.

Abraham Lincoln opposed slavery, but called the proclamation"...a fit and necessary war measure for suppressing rebellion... not an humanitarian edict. Many slaves escaped to the North; many were liberated as Union troops advanced. It was not until the Thirteenth Amendment took effect on June 19, 1865 that slavery was abolished.

Black Public Officials Plan Major National Meeting Before '88 Elections

(WASHINGTON, DC-N-NPA) - Plans for a national convention of some 1,000 top black elected and appointed officials just before the official start of the 1988 presidential campaign were disclosed here in the District of Columbia this week. Officials from all political parties will be invited in the nonpartisan effort.

The conference, officially termed the Fifth National Policy Institute will involve all black elected and appointed officials from throughout the nation. Conferees will develop political strategies, discuss public policy issues, and explore the problems of governance as they relate to

the Black community, according to the announcement.

Scheduled for January 20-23, the four day summit will be coordinated by the National Policy Institute of the Joint Center for Political Studies, an independently funded, black political "Think Tank". The Center's Institute program grew out of the fourth National Policy Institute of public officials in 1984, said Eddie N. Williams, JCPS president.


