Clark County Social Service Launches **Positive Parenting Project for Teen** Mothers

A well-known but unpopular statistic in Nevada is that the state consistently ranks in the Top Five in the country in the number of teenage pregnancies. Each year about 3,000 adolescents in Nevada become pregnant, giving birth to children who often have health problems or who become victims of child abuse or neglect.

To help combat the number of unhealthy babies born to teenage mothers and to reduce the potential for child abuse and neglect, the Clark County Social Service Department is implementing a pilot program beginning October 1 that is sponsored and funded by the Department of Human Resources Children's Trust Fund.

Called the Positive Parenting Project, the program will provide a way for new, young mothers to learn about the

importance of pre- and postnatal care.

"This is especially important in getting these young mothers to take care of themselves during their pregnancy so that their babies will be born at a normal weight," said Nancy Gott-Smith, vol-unteer coordinator for the Clark County Social Service Department, pointing out that a baby of a low birthweight is three times more likely to die than a baby born at a normal weight.

In Clark County alone last year, there were 1,221 adolescents who gave birth evidence of the necessity and immediacy of such a program.

According to Gott-Smith, volunteers from the community will be recruited and trained to work with pregnant adolescents as volunteer case managers. The volunteers will provide education

These volunteers will teach the young mothers about proper nutrition for themselves and their child. They also will stress the importance of abstaining from cigarettes, alcohol, and drugs during their preg-

In addition, the volunteers can help the teenage mother receive any social services she may need, such as housing, financial assistance, and clothing.

There have been a number of similar programs around the country that have proved successful. One such program in Ventura, California, worked with 101 pregnant teenagers last year and has 20 volunteers

Because it is a pilot program, the number of volunteers and teenage mothers will be relative small at first, Gott-Smith said. Plans are to have 10-15 teenage mothers and 10-15 volunteers.

"We need volunteers who are open-minded, empathetic, and can communicate with teenagers," she said.

• In 1985, Judge Bork wrote in the Foreward to Mc-Dowell's The Constitution and Contemporary Constitutional Theory, that "intent" has a specialized meaning, because judges must apply not just the actual intent of the Framers, but the 'principles' underlying the words of the Constitution and even the 'objects those principles are...intended to achieve.
