The Clark County School District has just entered into a five-year planning cycle that will propel the district into the 21st century. Most

No organization can hope of the residents of this county have a home, change careers, complete an additional phase of their formal education, or plan for retirement. Regardless of the age of the individual, there is a need to plan effectively and to be prepared to modify these plans as circumstances change.

So too, is there a compelling need for an agency, charged to provide education for more than 100,000 students to plan for the future. There is an old axiom that if plans are not prepared and used as guides, we are at the

mercy of circumstance. The district has selected not to be the victim of circumstance, particularly when such events could have a negative impact upon our youth, and the leaders of this community in a few years hence.

What then is Strategic Planning? For a number of years organizations have been confronted with an array of planning models. some highly complex and difficult to manage, other models designed to provide direction for only a segment of the organization's role and function. Strategic Planning is a planning process that involves a cross-section of proports to clearly and realistically speak to each of the significant elements of the educational and administrative process.

First, a committee of thirty members of our educational and lay communities has been requested to meet and establish a series of "belief statements for the district. This sounds simplistic in nature; however, it may be the single-most important component of the process.

Following this step there effort consensus was obtained on such a statement.

#### DACUM MEETING HELD AT VO-TECH

A DACUM planning conference was held recently at Southern Nevada Vocational-Technical Center. The conference, which was national in scope, brought together educators and business experts to collaborate on curriculum development for various occupational courses.

The term DACUM is an acronym for "Developing a Curriculum," and is defined as "an analysis of an occupation performed by expert workers in the occupation.

A DACUM evaluation team from Ohio State University facilitated the session in conjunction with occupational educators from Clark County Community College and the Clark County School District. Foreign educators from Singapore, Honduras and Jamaica were on hand as observers along with U.S. educators from as far-flung as Seattle and Florida.

Several local businesses volunteered staff members to work on the DACUM project. The teams met daily at Vo-Tech for 1 week. Their input was utilized to determine course content, objectives and what skills should be taught.
