Afro Americans Demand More Sanctions Against South Africa, View New Developments With Caution

WASHINGTON, D.C.-NNPA Afro American leaders protesting apartheid in South Africa expressed cautious optimism over the racist government's sudden release of five, veteran imprisoned Freedom Fighters during the past week, but called for continued United States public pressure to end the all white minority control of 24 million black citizens

A few days before the black Africans were freed by the white Afrikkaners, complete withdrawal of worldwide business form South Africa was called for at a Howard University conference on sanctions last weekend when several top black and white speakers from the country urged more direct protect action against rigid segregation ranging from economic boycotts to violent overthrow of the all-white government

Speaking on Howard's WHUR Radio immediately after the release of African National Congress leader Govan Mbeki, the Washington Office On Africa Director Damu Smith said the South African government was attempting to ease the increasing pressure for change and co-activist Gay McDouglal said the action indicates that the threat of sanctions is bringing results.

Trans-Africa lobby leaders who began street demonstrations here and throughout the world against South African embassies, were reluctant to comment immediately on the latest developments in the apartheid nation as U.S. sanctions hearings in Congress, continued turmoil

in the country and incrased oppression of the black majority focused more attention on the issues despite government censorship.

The release of Mbeki unconditionally after he served 23 years in prison for alleged treason caused speculation on the imminent freedom of South African hero Nelson Mandella and 14 other liberation leaders jailed at the same time. The surprise action was taken as the U.S. Congress debated increased economic sanctions over the objections of President Ronald Reagan and the State Department.

Mbeki's release may provide the beginning of dialogue between the exiled ANC, various liberation movement leaders and the apartheid government headed by Pieta Botha on steps toward majority rule in a democratic government, some observers at the conference, said later.

The Howard University conference, titled "Sanctions Against South Africa, What Works and What Doesn't?" attracted such leaders from the controversial nation as James Motlatsi, president, National Union of Mineworkers, SA; Beyers Naude, general secretary of the South African Council of Churches; M.J. Makatini, exiled ANC

Nevada Business Services Receives \$181,770 Award For Job Training For Nevadans

CARSON CITY - Governor Richard Bryan announced today that Nevada Business Services (NBS) has been awarded \$181,770 for exceeding all seven of the Department of Labor performance standards.

'NBS, for the second consecutive year, has far exceeded the national standards and its own goals for providing training and employment services to eligible youth and adults," said Governor Bryan. "83% of the youth participants were

either placed in jobs or were dropouts who returned to school. More than 70% of the adult participants were placed in jobs."

NBS's programs are targeted towards the employment and training of underskilled, low-income residents and special population groups with severe barriers to employment - youth who have dropped out of school, potential drop outs and older workers.

The programs include vocational assessment of parti-

Thirty-seven American ports a strong national defense, but the rationale for our involvement in the Persian Gulf, which is costing an estimated \$40 billion annually, is perplexing in view of the fact that over 93 percent of our Nation's oil supplies reach us without coming through the Persian Gulf," said Grand Polemarch Bacon. "Our presence there appears to be connected more with restoring the President's image, after the Iran-Contra Scandal, than it does with our National defense.'
