Kerry Files Legislation To Make the Minority Business Development Administration Permanent in Dept. of Commerce

Sen. John Kerry today filed legislation to provide a permanent home in the Commerce Department for the Minority Business Development Administration (MBDA) which has been the victim of repeated attempts by the Reagan Administration to reduce its stature.

The Reagan Administration has tried to transfer the MBDA from the Dept. of Commerce to the Small Business administration. Such a move would reverse the progress made by the agency over the past 18 years in promoting and assisting the nation's minority business community, according to Kerry. Sen. Pete Wilson (R-CA) is a co-sponsor of the

Money Available To Help Low Income Families Pay Energy Bills

CARSON CITY — Governor Richard Bryan announced to-day that \$2,040,597 is available to help low income families and individuals pay their energy bills.

Governor Bryan said, "The Low Income Energy Assistance program is designed to assist low income Nevada residents with the high cost of heating and cooling by paying a portion of their fuel or energy bills. Last year, the state was able to help more than 12,000 Nevada families through this program."

Like many social programs, the Low Income Home Energy Assistance Program has suffered in recent years from reduced funding due to budget cuts in Washington. Fortunately, Exxon oil overcharge settlement funds in the amount of \$2,-40,597 are available to supplement the reduced federal appropriations. Exxon monies totaling \$5.57 million will be used for energy assistance over the next two years

The program is open to anyone who is at or below 150% of the poverty level guidelines. Nevada uses poverty level figures established by the federal government to determine the maximum allowable income for

the program. A single-person household must be at or below \$687.50 for the previous calendar month, while a family of four must be at or below \$1400.00.

The Low Income Home Energy Assistance Program has been operated by the Nevada Office of Community Services since 1977. Each year the agency makes a special effort to target the state's elderly and handicapped. Many elderly and handicapped persons, who are returning clients and who live in a one or two person household, are encouraged to update their previous year's file by mail and need not go to their local intake center to


