CONGRESSIONAL PROBE INTO RACIAL HARASSMENT AT THE FBI **LAUNCHED IN RESPONSE TO GRAY LETTER**

WASHINGTON, D.C.-U.S. Rep. William H. Gray, III (D-Pa) today announced that the Senate Judiciary Committee has launched an investigation into the alleged racial harassment of a black FBI agent.

The probe is in response to a letter sent to the committee by Gray on behalf of Special Agent Donald Rochon. Rochon charges that he was the victim of harassment, intimidation and threats of mutilation and tigation of the matter. The death by white FBI agents committee will look not only in Omaha and Chicago. at Agent Rochon's case, but

the FBI's Philadelphia office.

In his letter to Gray, Sen. Joseph Biden, the chairman of the Judiciary Committee, writes that "Rochon's allegations, as described both in your letter and the Department of Justice Final Decision in this matter, are indeed alarming and certainly warrant investigation by the Judiciary Committee."

Sen. Biden goes on to say that he has instructed committee staff to begin an inves-Rochon now is assigned to also at the FBI's overall attitude toward its minority personnel.



Gray added:

"We have also received communications from the new director of the FBI, William Sessions, saying that the Rochon case has been referred for study and that he would keep us apprised of that inquiry.

Former State Senator Clarence Mitchell charged that the two year federal investigation of them accompanied by the harassing constant leaks to the press prior to their indictment, was part of a nationwide plan by the Reagan Administration to poison the climate of public opinion and to drive outspoken black elected officials from public office, as in post Reconstruction days.

Veteran political leaders see this as the Reagan plot to dilute black political gains from the 1965 Voting Rights Act, whose passage through the Congress was spear headed by their late father, Clarence M. Mitchell, Jr., Director of the Washington Bureau NAACP. The historic Baltimore City Court House is named for him.

We are being victimized by a corrupt justice department conspiracy far worse than Nazi Germany or Communist Russia, orchestrated by U.S. Attorney General Edwin Meese himself," said former State Senator Clarence Mitchell.
