course of seven albums, he solidified his standing as one of the great contemporary saxophonists. LPs like Friends and Strangers (1978) Flame (1979), and Every Generation (1981) took not only music fans by surprise, but also made a deep and lasting impression on his peers. Many artists owe Ronnie Laws a debt of gratitude for popularizing the sweet sound of the soprano sax, and for melding the best of Jazz and Pop styles. Yet, as All Day Rhythm confirms, Ronnie Laws can't be pinned down. "I don't see the new album as a change as much as a progression," he says.

It takes a solid measure of artistic poise to progress as fearlessly as he does, and much of that confidence comes from his family ties. "Aside from music, we're a very close family. Music is secondary to our relationships.'' Ronnie also has a family of his own: happily married for seventeen years, and with four children, Ronnie's favorite activity aside from making music is spending time with his family.

But he's never far from the music. "I'm a temperamental and moody person," he says. "I use music to express those moods." Judging by All Day Rhythm, Ron nie Laws has been in a very good mood lately. After eleven vears as a singular recording artist and composer, Ronnie Laws knack for producing consistently fresh and vital recordings, like All Day Rhytjm, is one of the music world's sure bets.




