NAACP AND ATLANTA HAWKS AND BRAVES REACH AGREEMENT

In an exchange of letters. the Atlanta Branch of the NAACP and the Atlanta Hawks and Atlanta Braves have resolved their differences over the implementation of affirmative action plans on the part of the two sports teams, and agreed to periodic meetings to assess the progress of those plans.

These actions, according to Julian Bond, president of the Atlanta NAACP, satisfy the concerns of the Branch and end the possibility of demonstrations being mounted against the teams

This possibility arose when earlier negotiations. looking toward the signing of a formal agreement with the teams, broke down. Since then, a series of meetings have been held between the NAACP and representatives of the teams leading to the exchange of letters.

"The Braves and Hawks have acted responsibly in addressing the broad issue of affirmative action. We have always said they are among the leaders in professional sports in this area, and now we are confident they will become even better," Mr. Bond said.

In the NAACP letter, Mr. Bond, Dr. Benjamin L. Hooks, executive director of the NAACP, and Ms. Jondell Johnson, executive director of the Atlanta NAACP, noted that the "commitment to ensure the Atlanta Hawks and Atlanta Braves fulfill their corporate societal resonsibility is an important step to bring blacks, women, and other minorities into the economic mainstream.

It was noted that the exchange of letters had the endorsement of the national office of the NAACP.

· "We will use, when possible, including but not limited to, such minority professionals as accountants and printers, as well as suppliers of equipment, uniforms and other goods and services.

· "We will continue to advertise in the local minority media, such as Atlanta Daily World, Atlanta Inquirer, Atlanta Voice, WAOK/WVEE, and WIGO radio .

· "We will continue to review and contribute to community service and philanthropic organizations .

. "We wish to continue our working relationship with the Atlanta Chapter of the NAACP and look forward to meeting . . . periodically to discuss our progress and entertain suggestions in the common interest.'

The negotiations with the Hawks and Braves are part of a national campaign by the NAACP to improve the status of minority employment in professional baseball, basketball and football.


