### VOTER REGISTRATION AND JESSE JACKSON

As we watched television on Super Tuesday, the results clearly indicate the importance of voter registration and voter education. Ninety-six percent of the blacks in the five Southern states that Jesse won clearly indicate the importance of registering and voting on election day.

Jesse won twenty-two percent of the Nevada vote without any money and very little organization. It all goes to show what great things we can do when we work together. Everyone who reads this article should make a personal pledge to him or herself to register everyone in his or her family, church or organization.

It's about time for us as black people to wake up and realize that *no one* is going to give us anything. We are going to have to rise up and take it for ourselves through the power of our own vote, just as they are doing back home in Tallulah, Louisiana and Fordyce, Arkansas.

Please don't allow another election day to come around in Clark County and you not be able to vote. Jesse encouraged blacks in the South to register and vote and their voting power was truly exercised on election day in Alabama, Mississippi, Georgia, Louisiana and Virginia.

Since 1909 when the NAACP was organized and had a very few friends to turn to, it has been able to depend upon the encouragement and support of the Black Church. During the

Civil Rights Movement of the sixties, churches throughout America and especially in the South gave financial support as well as served as meeting places for the NAACP branches.

Today, as then, we are requesting your continued help. From time to time, members of your congregation and your friends come to the NAACP for help and no one is ever refused. The NAACP helps those who are members as well as those who are non-members.

The NAACP needs your help in organizing a city-wide membership contest. There will be established three groups of churches and organizations according to the number of members in each church and organization.
