HENRY J. MOORE, SR. -Henry J. Moore was a star football player at Wisconsin University and Alabama State where he majored in chemistry with minors in mathematics and physics. He was a research chemist with the U.S. Bureau of Mines in Boulder City, Nevada when he became one of the only four Black teachers in Clark County, and the State of Nevada in 1947.

While at the Westside School from 1947 through 1953, Moore coached winning teams in basketball and track. And many of his former team members are now doctors, lawyers, school counselors and teachers. and some are in the Clergy. Moore ended his thirty-year career with the Clark County School District as a counselor at Western High School in 1979. Moore is married and the father of two children.

JOHN F. MENDOZA-John F.

Yvonne Atkinson-Gates has announced her candidacy for reelection to Clark County Board of School Trustees as the representative of District C.

She originally joined the board in April of 1985 by appointment in a field of several candidates vying as replacements for Virginia Brewster who resigned after being reelected. Atkinson-Gates has since won reelection. And now she tosses her hat into the ring once more.

Gates sponsored the firstever Town Hall Meeting at Nucleus Plaza, bringing the school district administration directly to the citizens.

'My intent was to make it possible for district staff to be in an area where parents and students would feel comfortable in expressing their interests in familiar sursoundings." And, Atkinson-Gates stressed, "The experiment worked extremely well!

Another of her endeavors was a College Fair at Doolittle Recreation Center. Assisted by PACE, she arranged for college information to be provided by educators who also dispensed advise to students regarding college application and scholarships.

Not content with resting on her laurels, Atkinson-Gates went on to establish four classes on Parenting Skills and Techniques at Clark County Juvenile Court Services.

Perhaps the most recognizable accomplishment of her early years on the board was the Summer Kindergarten Program. Although not established on a permanent basis, the summer program proved so successful that it is still under consideration for extended funding.

When Just Say No To Drug chapters were starting to organize in Clark County, Atkinson-Gates arranged to have a reknowned anti-drug expert speak at a community meeting at Las Vegas High . School Auditorium. And, since the establishment of Drug Abuse Fesistance Education (DARE) programs in several Clark County Schools, she has been fully supportive.


