POETRY SHOWCASE AT CLARK COUNTY LIBRARY TO FEATURE RUDI JACKSON AND DIKKI EURE

The Las Vegas Poetry Group will present "Poetry in Motion" at 7 p.m., Wednesday, May 18 in the auditorium of the Clark County Library, 1401 E. Flamingo Rd. The public is invited to the free program which will showcase the poems of local

Poets Rudi Jackson, Frank Vivert, Louise Bardon, Robert Byron Horn, Dorice S. Sager, Dikki Eure, Kim Fitzgerald and Twila Anne Rogers will read their poems.

Jackson started writing poetry, primarily song lyrics, at the age of 10. One of his songs, "Hearts of Stone," was a top ten hit and was sung by such entertainers as the Fontaine Sisters, Red Foley, The Charms and others. He sang the original recording with a vocal group known as The Jewels. In the 60's, Jackson was associated with the Watts Writers Workshop in Los Angeles; in 1978 he moved to Las Vegas, and joined the Las Vegas Poets Group. Jackson who uses the pen name Mon-amodi meaning "He who comes to help his brothers," has been the group's director for four years. He will read and dramatize his poem 'Jackson Avenue.'

Vivert, retired electrical worker and Las Vegas resident for the past four years, has been writing poetry for 15 years, recently winning second prize and two honorable mentions in the statewide Calliope Poetry contest. His prize-winning poem "They Call Me Meg" reflects his concern for street people. "Caliban" will be read by him, accompanied by a film about coal workers.

Bardon will present her poem, "The Merry-Go-Round." Several of her prose-poems were recenlty publicly in S.S. Calliope and Pegasus.

Horn said "I am a glass shadow on the high wire who writes poems where there is a loss of balance. Two of my major influences have been Fyodor Lopukhow and Vitezslav Nazval. I am presently being educated by my seven year old nephew on how to be a child." He will dramatize his poem "A Play Before Death.

Sager, who has written poetry for years, has been published in local newspapers and magazines, as well as anthologies in various states. She plans to read "Silken Dreams" which appeared in the March issue of

S.S. Caliope. "It is about the joy of spontaneous enactments of the creations which live around us every day, she said

Eure said he is an ex-drug addict who is now "getting great natural highs" by expressing himself in poetry. He'll be reading an original poem titled 'flip! flop poem titled ''flip! flop flam?'' which will be dramatized by Wyleaner Spring-field and Howard Fortson in 'freeform rhythmic style.'

Fitzgerald's choice is called "Diner." She said it is a true account of a visit to a small town in Idaho.

"Princess Snowflower" will be read by writer and poet Twila Rogers. She was formerly a staff writer and columnist for the Temple Daily News. Her work has appeared in local and Arizona newspapers. Sunday afternoon, I felt something pulling me "like a magnet" to Calico Basin in Red Rock Canyon," she said. "I began to walk back in the canyon when I heard someone following me. No one was there, but I strongly felt the presence of an Indian Maiden. She told me her name was Princess Snowflower, and thus became the inspiration for my poem.
