parents, a trend that has been reversed during the Reagan years. The rise of interest rates and fouring prices have left young people with less discretionary income, while older Americans who could more easily afford homes in the prosperous 1950s and 1960s, have fared somewhat better in terms of property wealth, but are faced with rising prices and maintenance costs on fixed incomes.

In addition, job creation has not kept up with the surge in the workforce. And most of the new jobs being created are in the lowest-paying industries. The number of jobs in the highest wage industries — service as well as goods-producing — has declined.

Clearly, the economic pic ture for most American workers and the poor is uncertain.
