Recently I witnessed two (2) NLV Police and three (3) Metro Police brutally beat a young Black man AFTER he was handcuffed on "H" and McWilliams Streets. I yelled to the police to stop kicking and hitting him and to stop violating his rights. I was yelled at and threatened with being arrested for speaking out against their actions.

Rumors have it that the young man was possibly a gang member or a drug dealer. I do not condone this type of thing, but I will not stand by and tolerate the police beating anyone excessively, especially when they are already handcuffed.

After Channel 8 did a news story on the incident, several people have contacted me and told of similar incidents of police brutality, but they were afraid to come forward or did not know how to go about filing a complaint.

We must report all incidents of this type. We cannot let our neighborhoods be policed by some individuals using the same tactics as South Africa's police nor can we subject ourselves to the same treatment as that of the

We do want to rid ourselves of the gang and drug problem, but not having our rights violated in the process.

when you go to file a complaint with either police departments and the FBI. You will be interrogated. The Metro Police Department will try to intimidate you and will ask you plenty of "what if" questions to try and make you change your story or stretch the questions to make it apepar that you did not see what you did. You will be made to feel you are the criminal instead of the witness who observed the police breaking the law. But stand your ground and tell the truth.

The police must realize that we want to work together with them to make our neighborhoods safer, but we will not tolerate police brutality.

I also advise anyone who is being arrested to yell to any bystander your name and a phone number of a relative to help insure you stay in good health after you are taken to jail, and hopefully the police will hesitate before brutally beating you.

Get the policeman's name and badge numbers and car numbers.

Attention! The young man that was brutalized on "H" Street, please contact me. Don't let them intimidate you into not filing a complaint. Stand up and be counted and don't be afraid to speak out.

Vegas Woman Stable After **Heart Transplant**

A Las Vegas woman received a new heart during an organ transplant operation at a Phoenix, Ariz., hospital Wednesday, where she is reported in critical but stable

Leslie Randolph, 28, re-ceived a new heart from an unnamed donor during an operation lasting more than two hours Wednesday evening at Humana Hospital.

The single mother of three is doing "much better than expected," and by Thursday was taken off breathing support systems, said Teresa Gray, director of transplant services for the Arizona Heart Institute.

Randolph was diagnosed two years ago with congestive heart failure, and her condition has worsened since August.

She was out of surgery by about 7 p.m. Wednesday and has seen her mother, Linda, who was staying at a Phoenix hotel

Randolph's children -Cortney, 6, Ashley, 5, and Aaron, 3 - were staying with family friends for Thanksgiving,
