DR. KENNEDY LEADS NEW EXECUTIVE BOARD AT DELTA

WASHINGTON, D.C.—The new executive board of Delta Sigma Theta Sorority, Inc., met recently at the Omni Shoreham Hotel in Washington, D.C., led by National President Yvonne Kennedy.

Dr. Kennedy, an Alabama state representative of Mobile, Alabama, was recently elected party leader of the House Unified Democratic Caucus. She will be responsible for guiding major legislation through the Alabama legislature.

In terms of percentage, Alabama's black legislative contingent is the largest in the nation, with 19 black members of the House and five in the Senate. Dr. Kennedy is one of four black women legislators and has served the longest of the four. Dr. Kennedy is also president of Bishop State Junior College in Mobile.

The recent Omni Shoreham meeting in Washington was the first of her new administration at Delta Sigma Theta.
