enough money to go around. The hard reality was, not only did the Reagan Administration cut hard into the bone of social programs, but they also created a fiscal crisis that puts the future funding of these programs at risk.

In the short term, the "no tax read my lips strategy" is prose for politicians, but it ignores the hard realities ahead. These realities are: educating a workforce, especially children of the poor, to make us competitive; rooting out the menace of drugs and crime in our nation; a rapidly diminishing availability of affordable housing; and the general decline of our manufacturing base. The short term policy, of not even considering the "T" word, is a way of deferring the problem into future years.

But the policy of this indifference on budget priorities, which invest in people, has already begun to unweave our social fabric. Some examples are: the homeless, increasingly children and families (a lack of public housing); high joblessness and crime in our inner cities (a lack of comprehensive urban policy); high school dropouts (a lack of proper investment in early childhood education); and, child care (a lack of affordable and quality care). These observations are sometimes criticized by some as "prophets of doom and gloom." We cannot simply represent the

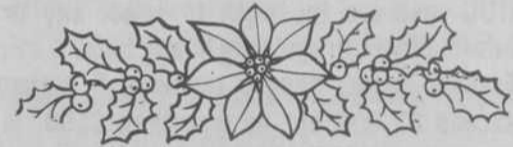
