Whether in response to the popular Las Vegas Convention and Visitors Authority advertisement: "Las Vegas, the American Way to Play. and Met," or just a natural desire to visit a new area, there is conclusive evidence that Las Vegas is attracting a larger share of black conventions

From 1989 through 1992 there are no less than 14 black groups that have confirmed the "entertainment capital" for either a board meeting, a regional conference, or a national conclave.

The free-standing, copperroofed building, located at 951 W. Lake Mead Blvd. repalces the old library, which had been housed in a store front on "D" Street for


the past 15 years

Most of the money for the building and furnishings came from state and local library bond funds in addition to a small amount which came from federal block grant money alloted to the library by Clark County. The \$1.35 million does not include the cost of books or building was built on land donated by the city of Las Vegas, and stands adjacent to the Doolittle Community Center

In accordance with the wishes of community members, the library hours will be shifted toward the evening and the weekend. It will be open from 1 p.m. until 9 p.m. Monday through Thur-
