"WONDERWORKS" "RUNAWAY" FOLLOWS ADVENTURES OF YOUNGSTER ON THE LAM IN NEW YORK CITY

Wonderworks presents a new story about a 13-year-old latchkey boy growing up in the threatening world of New York's urban ghetto in "Runaway," airing Saturday, February 4, 1989, 8:00 p.m. ET, during public television's Black History Month.

Based on the novel *Slake's Limbo* by Felice Holman, "Runaway" is about young Aremis Slake (Gavin Allen) who is being carefully raised by his impoverished aunt, Anna Mae (Hattie Winston), in New York City.

A favorite pastime for Aremis and his friend, Joseph (Kevin Artis), is collecting useful but discarded articles for a project they are doing at the local neighborhood Friendship Center. The collecting trips frequently take the boys into the subways and other "turfs" of a hostile gang of toughs who wait

to prey on the two boys. While trying to escape from one such attack, Joseph is involved in a severe accident and Aremis is blamed for the mishap by authorities.

The incident sends Aremis into hiding deep within the tunnels of the subway system under Grand Central Terminal. There, he is befriended and protected by a wheelchair-bound Vietnam veteran (Charles Dutton) and a waitress at a Grand Central coffee shop (Jasmine Guy). After a series of adventures and near disasters, Aremis is eventually reunited with his aunt and the social worker from the Friendship Center (Kim Staunton).

"Runaway" is a production of Limbo Productions, Ltd. in association with Pacificon. William L. Wallace is executive producer. Bill Baynes is coexecutive producer, with Peggy Zapple as

producer. Gilbert Moses directs.
