SOUTHERN NEVADA CLEAN COMMUNITIES COMMITTEE -This county-wide organization (non-profit), which is part of the national "Keep America Beautiful Campaign" has involved volunteer citizens in cleaning up Clark County from the Arizona border to Mt. Charleston, and Laughlin to Mesquite for the past few years. This organization is available to assist us in cleaning up the West Las Vegas area. Their telephone number is 796-5050.

STREETS AND SIDEWALKS IN WEST LAS VEGAS - More than \$2,000,000 in Community Development Block Grant Funds were used to install streets, curbs, side walks and street lights in West Las Vegas between 1976 and 1985. The City of Las Vegas is now in the process of completing this community improvement project beginning Monday, June 19, 1989 with the improvement of North "H" Street between West Washington Avenue and West Owens. This project will also include curbs and gutters and sidewalks.

Ours (West Las Vegas) is one of the most visible residential communities from I-15 between West Bonanza Road and West Cheyenne Avenue. This is the first residential community seen by motorists going south on I-15 and the last seen by travelers going north.

Let's keep West Las Vegas clean and beautiful, and a pleasant sight for tourists and home folk alike, as they travel 1-15 through Las Vegas.
