BLACK HISTORY

BECKWOURTH

James P. Beckwourth was born in Fredericksburg. Virginia, the third of thirteen children. His mother was a Negro slave for his father, a white officer in the Revolutionary War. He completed four years of schooling and later was an apprentice to a blacksmith in St. Louis for five years. At eighteen, he ran away and had trouble finding work because of his mixed blood. In 1823, he joined the expedition of Gen. William Henry Ashley's Rocky Mountain Fur Trading Company, which penetrated the western wilderness. James Beckwourth became an excellent hunter and expert fur trader. He quickly picked up the ways of the Indians and learned to speak their language. He was accepted by the Blackfoot and the Crow Indian tribes and became one of the greatest Indian fighters of his times. The Crow Indians made him a chieftan and called him "Bull's Robe." He became a mighty warrior and took part in their intertribal wars and according to Beckwourth "lifted the scalps of many an enemy."

In 1837, Beckwourth grew tired of the savage life. returned to civilization and established two trading

Seminole War in 1842 and the California Revolution in 1846. In 1848, traveling with his wife, he met General John C. Fremont and became his chief scout. On this expedition in 1850, Beckwourth made a discovery that "should forever secure him a place in Western history. Just a few miles northwest of what is now Reno, Nevada he found an important pass through the Sierra Nevadas. He personally led the first wagon train of settlers through "Beckwourth Pass" followed later by thousands of pioneers and gold seekers to the fields of California. The Western Pacific railway later used the "Beckwourth Pass'' as a gateway to the West.

Beckwourth's last adventure took place in 1866, when he fought in the Chevenne War. He died in Denver the same year of mysterious causes. Legend had it that the Crow Indians honored him at a farewell feast to propose that he stay with them and lead them to greatness again. He refused and it is said that the Crow Indians poisoned him to keep his body and powerful spirit within their land.
