## Las Vegas Housing Authority Again Under Fire

The City of Las Vegas Housing Authority again came under fire this week, when the newly-formed Housing Authority Board elected Carl Rowe as the Authority's Executive Director. Rowe, who has no experience in public housing, was chosen over four other candidates all of whom had had previous experience as administrators in public housing.

Gail Gonzales, one of the most vocal advocates for tenants' and employees' rights and for Housing Authority reform over the past few years, has called for the resignation of Louis Conner, the newly appointed-Chairman of the Board. According to Gonzales, Conner, who was just appointed to his new position two weeks ago, and who, as Chairman, has the deciding vote, had promised the tenants' and employees' group that he would vote for their choice , Monroe Watson, for the Executive Director post. Conner, however, cast his vote for Carl Rowe.


As a result Gonzales and her group began a boycott last Sunday of the Seven Seas Seafood Restaurant and Lounge, which is owned by



Conner, saying that if Conner won't assist and abide by the wishes of the people, then the people won't spend their hard earned dollars at his restaurant.

Gonzales stated further, that if Conner doesn't resign, her group will push for Mayor Ron Lurie to fire him.

The Sentinel-Voice attempted, but was unable to get a comment or statement from Louis Conner.
