creases racial segregation; 3. Deliberately utilizing grade structures which create or maintain racial segregation;

4. Practicing racial discrimination in hiring, assigning, promoting, and demoting administrators, teachers and school support staff; and

5. Failing or refusing to develop or select classroom textbooks, and other curricula material which accurately reflect the role played by blacks in this country.

The Plaintiffs have asked the Court to quickly schedule

a Hearing at which they may submit testimony and other supportive material for their request that this lawsuit be certified as a Class Action, and that they be certified to represent all black students entitled to attend schools in Clark County.

Representing the Plaintiffs in this lawsuit will be Las Vegas Attorney Geraldine Kirk-Hughes; Thomas I. Atkins, former General Counsel of the National NAACP, from New York City; and Peter Graham Cohn of San Francisco and Petaluma, California, former member of the NAACP's National Board of Directors. Both Atkins and Cohn have had
