New York, March 15--The 100-year-old son of a former slave, who has earned 11 college degrees, including five in law, believes that blacks are finally making progress and said the young

"There is less prejudice today," John Morton-Finney told PARADE Contributing Editor Wallace Terry, who insomething no one imagined when I was a boy--run for President. When Doug Wilder was elected governor of Virginia, it was the biggest surprise to me since a black

man was elected mayor of Chicago. And you don't know how much the appointment of Colin Powell, a black man, to be chairman of the Joint Chiefs of Staff means to me, an old soldier. It turned the world upside down.

Asked how he could fight for a country that discriminated against him, Morton-Finney, who served in World War I, said, "It was still my country. There was no country in Africa that I belonged to. This is where I lived. I believed I should fight for this, my country. And I would do the same today

Born in Uniontown. Kentucky, after his father had been freed by President Lincoln's Emancipation Proclamation, Morton-Finney developed a penchant for learning early on that has never stopped.

"A cultivated man would never say, 'I finished my education' because he graduated from college," he declared. Fluent in six foreign languages, Morton-Finney holds bachelor's degrees in mathematics, French and history and
