4. That homes which are a threat to human life must be condemned immediately.

The proposal which they

were offered by HUD was far from what most of the residents desired. Windsor Park homes are owned by HUD and the property is owned by the City of North Las Vegas. HUD asked the homeowners to sign over their deeds to their homes to it and then lease another HUD home for a term of one year. By signing their homes over to HUD, the homeowners would have avoided foreclosure on them. After having leased the home for one year, they then would have an option to buy, that is, if they are qualifiable. The monthly rent that they would pay on the house to that one year term could be sed as a down payment on the mortoage. Five residents of Windsor Park accepted this proposal out of desparation and fear for their families'

When a house starts shifting and moving, it breaks electrical lines and gas lines, cracks foundations and causes astronomical repair bills for the homeowner. Windsor Park has gas lines and electrical lines running beneath it and, sadly, simultaneously breaking. If a

Court's actions.

In effect, the Court has sent a terrible message to America -- that it is drilling loopholes in anti-discrimination laws and minority rights may be violated.

Now, the Congress must send a positive message to both the Court and the American people -- that discrimination will not be tolerated.

The proposed Civil Rights Act of 1990 does that, and a measure of its probable effectiveness are the alarm bells set off among its opponents who are waging an all-out effort to defeat it.

They're claiming that a new law is not necessary -- despite the overwhelming evidence of gross disparities between African Americans and white workers that scholars have found is largely due to discriminatory practices.

They charge the Civil Rights Act of 1990 is a new affirmative action law and raise the specter of quotas, when it is nothing of the kind. The proposed law would simply restore employment practices to where they were before the Court acted.

It doesn't even address damaging affirmative action decisions, such as the Court's overturning a city minority set-aside purchasing program. If

Miss Walker and her associates feel that something must be done to correct what has happened and taken place in their community. anything, Congress needs to undo that decision.

Critics also want to scrap the provisions of the bill that allow victims of discrimination and harassment to sue for damages.

It seems to me that when the judicial system finds that someone is wronged, they should be entitled to compensation. Otherwise, the perpetrator gets away free.

And where the courts find gross, intentional violations of rights that warrant punitive damages, such punishment should be enforced.

Those means of redress are an integral part of our justice system, routinely applied to other forms of victimization. Refusing to apply them to discrimination cases is itself discriminatory -- a way of saying that bias is a minor misdemeanor, like a parking ticket.

By restoring the right to sue for compensatory damages, the bill helps to make anti-discrimination laws largely self-enforcing, just as product liability claims force manufacturers to do a better job of ensuring that their products are safe.

It is urgent that this propsed new law be passed without delay. The last time Congress tried to overturn a Court decision that encouraged violation of basic civil rights, it took four years to pass.

With discrimination so common and the legal tools to counter it limited by the Court's actions, we can't afford that long a wait. Congress and the Administration need to enact into law a measure that would roll back last year's Court challenge to justice and fair play.

Although Williams and Smith have only been there for several months, Chief Burse and his staff have a long list of experiences in private security for a number of years. Burse is a soft-spoken, no-nonsense professional security chief, with a competent able-bodied staff of officers who know their job and take it seriously. He and his staff know the dangers of the job and take all necessary precautions to maintain the safety and security of all residents. He said it was Williams' commitment to security that cuased him to take the job.

"Ms. Williams and Ms. Smith have been extremely supporting of me and my staff. They have supplied us with the state-of-the-art communications radio equipment and made no fuss about money when things were needed. It was their commitment that caused my decision to take this job. We are dealing with drive-by shootings, gang warfare, drug trafficking and the like, and you must be adequately equipped to be effective," he said. "We were not used of this kind of commitment in some of our past jobs. That's why we know we can make a difference."

Burse also was kind enough to offer this Sentinel-Voice reporter and our Marketing Director, Ramon Savoy, an opportunity to ride with them on a typical security run-fully equipped with bullet-proofed vests. We intend to honor his offer at a later date.

In the meantime, Carey Arms Apratments management and the CIA will be giving each other enough time to come together and make a difference for the good of the entire community.

Since the new management and security staff have taken over, drug trafficking, gang violence, and theft have all significantly decreased. The security team has assisted the North Las Vegas Police and Metro on several occasions and are highly regarded by both departments.
