
THE NAACP AND YOU!

committee. The purpose of this report is to assist you in becoming better acquainted with the activites and involvements of your NAACP.

LAS VEGAS BRANCH NAACP THREE YEARS OF UNPARALLELED HISTORY

In just three short years this branch membership, executive committee and its president have been more than successful in its programmatic thrust of extending hope to the hopeless.

Beginning in January of 1987, this branch had three hundred members, the office was located at the intersection of W. Owens Ave. and So. Main St., just outside of the black community, no money in the bank, no credit and three months arrears in the office rent.

Since then the branch has located within the black community, the rent has been reduced from \$450.00 per month to \$220.00 per month and a membership increase to more than 600 members.

All bills are paid and the branch has a good bank balance. The president was also instrumental in encouraging Alpha

notice through the weekly writing of the president in the Las Vegas Sentinel-Voice newspaper. "The NAACP and You" announces meetings and activities.

"The Word of God" Broadcast is heard every Sunday morning on KCEP radio station - 88.1 on the FM dial at 6:30 a.m. The message of the NAACP is heard by a listening audience of approximately 100,000 people.

Countless numbers of press conferences and press releases have been issued setting forth the NAACP position on many different issues by the president.

In the Spring of each year the NAACP and McDonald's Corp. have jointly sponsored job fairs to bring job seekers and the employer together for those young people who could not find employment for themselves.

NAACP Jubilee Sunday is held once a year and the public is invited to celebrate the signing of the Emancipation Proclamation which set the slaves free form physical slavery.

The Freedom Fund Banquet under the chairmanship of Mrs. Juanita Simmons, Dr. James McMillan and Mrs. Ida



Gaines has grossed more than \$50,000.00 and provided in the form of Freedom Fund Assessment to the National NAACP more than \$17,000.00.

The NAACP Complaint Committee through the leadership of its chairman Mr. Thomas Leigh meets every Tuesday at 7:00 P.M. in the branch office and has processed more than 100 complaints per year.

A Voter Registration Committee has also been formed under the leadership of Mrs. Geraldine Leigh who works during the week and on weekends in shopping malls and elsewhere registering people to vote.

The NAACP membership has increased decisively due to the membership committee and the dynamic leadership of Mrs. Juanita Simmons. During Mrs. Simmons' convalescence, the work of the membership committee is being carried on by Mr. Sam Wright. The Resource and Development Committee under the leadership of Attorney Aurthur Williams has been, and is, a vital adjunct in providing manpower, technology and general assistance to other committees. Attorney Williams is doing a magnificent job in encouraging other black professionals to get involved with the work of the NAACP.

The ACT/SO Committee, under the tenacious leadership of Mrs, Anika Johnson encourages our black boys and girls to stay in school and excel in the classroom just as they excel on the football field and basketball court. This branch has invested more than \$10,000.00 in this program.

Under the courageous leadership of the branch former president, Dr. James McMillan, this branch is a part of the Clark County School District integration plan. The branch gave a unanimous vote to support the Black Educators of Clark County in their lawsuit against Clark County Schools. The lawsuit charges the school district with a failure to educate black boys and girls. An elementary school has been named in honor of Dr. McMillan. Dr. McMillan has given fantastic leadership to this committee.

This branch has purchased a computer to keep its membership updated and a newsletter to members and the public. This program is under the capable leadership of Mr. Sam Wright.

The NAACP Black Dollar Days Committee is headed by Mr. Ernest Fountain, who will demonstrate to both black and white establishments the actual, as well as the potential, power of black controlled dollars.

The NAACP Legal Aid Committee is designed to give legal assistance to those who can least afford it and is headed by Attorneys Thomas Peterson and Kay Bennett.

_The NAACP Freedom Fund Banquet '90 Chairperson is Mrs. Yolanda Arrington, who is assisted by Attorney Arthur Williams.

The office personnel and office committee headed by Mr. Sam Wright, along with Mrs. Verlia Davis and Attorney Arthur Williams, is in the process of acquiring office furniture.

The Finance and Audit Committee, staffed by Mrs. Teola Williams, Treasurer, Mr. David Hoggard, a former branch president, and Mr. Sam Wright, has done well with its duties.

Computerization of the NAACP membership and the publishing of the branch Newsletter ''NAACP Today'' has been realized through the skillful and intellectual hands of Mr. Sam Wright.

If Duke wins the Republican primary, the November election will have profound national implications. What will the stance of the Republican National Committee and the Republican Party led by President George Bush and Mr. Lee Atwater be? One of the leaders of the Louisiana Republican Party, Mr. Neil Curran stated, "Many party leaders are afraid of antagonizing those people David Duke has been able to mislead thus far in his one-way dialogue."

The politics of racism must not go inchallenged in Louisiana or anywhere else in this nation. It is long overdue for the Republican Party to speak out against all forms of racism including the antics of politicians like Davis Duke. The President of the United States should have the courage to call on the people of Louisiana to reject racism in the political process.

We believe one of the reasons why President Bush is rather soft in his denounciation of apartheid in South Africa is because he is also soft in his denounciation of racism here in the United States of America.
