could accomplish some of their community objectives.

Tom Gholson, Deputy Executive Director of the L.V. Housing Authority, gave the SENTINEL-VOICE some historical input on what led to the closing of the centers: the collapse of the Sartini administration was at the helm; the financial reorganization of the Housing Authority; and the budget constraints placed on the Housing Authority by HUD due to the Grand Jury investigation which is presently underway. All contributed to the decision by the board to take cost cutting measures which led to the consequent closing of all eleven of the youth centers.

Gholson said that after only two weeks on the job, he received a mandate from the Housing Commissioners to look into the requests for re-opening the Centers. Gholson reiterated the fact that no policies were established and considerations were not made as to the eventual re-opening of the Centers

The youth centers were closed in January of 1990 and the Boys and Girls Club and NALA submitted proposals on December 15, 1989, while Gustavos Ramos was Acting Executive Director. A preliminary memo was sent to Mr. Ramos dated December 7, 1989 by Susan Ernst, Housing Board Commissioner, recommending that a hearing be scheduled to approve a contract for facilities to be awarded to the Boys and Girls Club, who had met the renovation requirements set by the Board of Commissioners. At that time there were no other proposals for the A.D. Guy Center submit-ted...After competition for the Centers surfaced, then we decided to start developing criteria...The MLK Committee did not submit their proposal until February...

THE SENTINEL-VOICE interviewed Louis Conner, Chairman of the Housing Commission. Conner was adamant about his position on the A.D. Guy Center.

He said that the issue has gotten out of hand.

"We (the Board) have been trying to get the Boys and Girls Club to locate in West Las Vegas for a number of years and they had not responded...Finally we have a well-funded organization that is being located in our community and then we start attacking it...This organization is well-funded and self-sufficient...They applied for Block Grant Funds to get started, but I guarantee you after about a year, they won't need any funding...Most groups that get funded keep coming back for funds...So they are an asset to the community,'' he said

When asked about Mayor Lurie using the renovation project as a political football, Conner responded that the Mayor wanted to see a strong youth program in West Las Vegas and he felt that the Boys and Girls Club was such a program, not just because the Mayor happens to be the President of the Boys and Girls Club.

Dora Miller, President of the Martin Lughter King Committee said it was the "same old game." She said that the MLK Committee doesn't like the way the Mayor went about acquiring the A.D. Guy Center.

where the powerful colorproducing genetic material is stored

-"'That Whites do indeed desire to have colored skin can be seen by anyone at the very first signs of spring or summer when they begin to strip off their clothes...in an attempt to add some color to their white, pale colorless bodies.

Those are some of Welsing's theories. She's not easily dismissed as being a kook. Attesting to her credibility, she is one of the 36 "Legends of Our Time" celebrated in the current month's issue of Essence magazine.

When asked to defend her theories through explanation. Welsing responds, ''!'m saying that White people must first acknowledge that something awful has been going on, just as the Germans would have to accept responsibility for what they did in the Holocaust. Unfortunately, in White America, there's a denial among 99 percent of the people that anything has happened.

"If they read my book, they would see I'm asking White people to respect themselves. Because if they respect themselves, they would respect others and get along with the other people on this planet instead of killing them off.

Ironically at the mention of Public Enemy, Welsing says she has never met the group. nor does she even know who they are!

Within the context of her theories, Welsing defines racism as "a global system of behavior that exists for the purpose of White genetic survival

She says she understands her theory is disturbing to some, but says science can be disturbing. "If you don't like the truth, you kill the person who speaks it. But it's still the truth," Welsing said.

Isn't it strange that the same rap music that many of us as mature adults dismiss as being nonsensical can be the catalyst for the dynamic presentation of scholarly viewpoints relative to our own race?

In my wildest dreams, who would ever have thought the professional paths of a Black social psychiatrist and a rambunctious rap group could embrace a common theory? And to those who say rap doesn't have a message in its music...that won't work anymore! Rap music has indisputably come of Go age. 'head.....go....'head.....go

'head!
