season for two games for missing a practice.



As a junior she earned all-American honors running a leg of the 4x400 meter relay at the NCAA outdoor championships.


The 12 players selected from the trials, to be held May 17-22 at the Olympic Training Center, will represent the United States in both the Goodwill Games and the World Championships this summer.
