HEALTH DISPARITY WIDENS

The correlation between health status and race in the United States of America exposes another devastating reality concerning the impact institutionalized racism has on American society. One truism is that it is unhealthy African-Americans, Hispanic Americans and other racial ethnic persons to live here because of racial discrimination in the delivery of health care.

A new report released by the Department of Health and Services titled. Human United States 'Health: 1989", concludes that the infant mortality rate for African Americans is double that of Anglo Americans. Dr. Louis Sullivan, Secretary of Health and Human Services, reported to the Associated Press, "This concerns us greatly...we need to move toward equal health oppor-

tunity for our citizens, including the good health formation and the family and community support that will help every American make the right choices for healthy and productive lives.

The report was the 14th annual report on the health status of the United States. We have monitored these reports during the last ten years, and we have found that the health status of the African American, Hispanic American and the Native American communities has steadily declined in the quality of health care.

This latest report is even more disturbing because it shows the decline in the health status of racial and ethnic communities at a time when the overall health status of the United States is improving. For example, the

To Be Equal

LAW ENCOURAGES

It's four years now since Congress passed an immigration control law that included penalties against emplovers found to have hired undocumented aliens.

At the time the law was being debated, civil rights groups warned that such a provision would be an open invitation to employers to practice discrimination.

It seemed obvious that, rather than take the risk of Hispanics, Carib-Asians, or other hiring beans. workers who might turn out to be illegal immigrants, many employers would simply stick to hiring native-born whites.

The law was supposed to prevent such discrimination its supporters argued that all employers had to do was to get proof of legal residen-

But many employers didn't want to get involved with such paperwork or decided the risk of being hit with penalties if some undocumented workers slipped through their efforts was too great.

As a result, the government has found widespread discrimination.

A study of the effects of the law was released by the General Accounting Office, a federal agency, in late March. It found that about one out of five employers surdiscriminated hiring.

Many refused to hire any job applicants who had a 'foreign appearance or accent." Others wouldn't hire anyone who was not a U.S.

To supplement the survey, the GAO sent out pairs of

"testers" to 360 employers selected at random. One was Hispanic-looking; the other, Anglo.

The report found that Hispanic testers were three times as likely to be treated unfavorably, while the Anglo testers got 52 percent more job offers.

It is clear that in attempting to control illegal immigration, the government is encouraging illegal discrimination.

The policy that requires employers, in effect, to act

as agents for the Immigration and Naturalization service. has resulted in gross violations of civil rights.

And while the primary effects appear to be heaviest among Hispanics, black immigrants from Haiti and other Caribbean lands, as well as Asians and other foreignborn persons are also prime targets of employment discrimination.

law The includes a "sunset" provision that requires Congress to consider repeal if, after three years, there is evidence that it is causing widespread job discrimination.

The GAO study has certainly proved that it has, but there's considerable political resistance to reopening an issue the Congress thought it finally had solved by passing the law.

Instead, some urge adoption of a universal workersystem, identification probably in the form of a national identity card
