This is the fourth and concluding segment of my series on "The Cress Theory." If you knew little or nothing about Dr. Frances Cress Welsing and her Cress Theory of Color Confrontation (White Supremacy) before reading this series about her, I hope you have been at least somewhat enlightened.

The question emerges when I come across a controversial body of knowledge such as the Cress Theory, "Is the glass half-empty, or half-full?"' As you review Dr. Welsing's theories, that lingers, same question because she deals with race relations from a totally unique perspective rarely portrayed through the normal methods by which we receive the information on which we base life's decisions.

In case you missed my previous description, the Cress Theory is an explanation of white supremacy behavior at the global and local levels in terms of the prevailing patterns of domination which are operative against Blacks in all aspects of our daily lives.

Is there a solution? Does Dr. Welsing offer a way out? The answer is an unequivocal. "yes!" Referring to her chessboard analogy where white squares represent white people and black ones--Black people. The white side is playing genetic sur-





vival while the black side is passively reacting. Dr. Welsing poses the question, 'Are we ever going to be able to master the black side of the chessboard?" She urges. "We must stop asking other people to help us solve our own problems. We should be proactive in solving them ourselves!'

While that may not be a dramatically new direction, it certainly charts a new course and a new direction of thought for Black people everywhere to rally around, and hopefully, to follow.

Nation's Black Doctors Plan Las Vegas Convention

LAS VEGAS - The Board of Trustees and officers of the National Medical Association met here recently to plan the 95th Annual Convention and Scientific Assembly of the nation's Black physicians to be held here at the Bally Grand Hotel, July 28-August 2.1990.

'We are on the front lines for those who are medically underserved and disparately by potentially le or curable affected preventable diseases," declared Vivan Pinn-Wigins, M.D., W of Washington, D.C., NMA's president. She is chairperson of the Department of Pathology at Howard University's college of medicine.

The NMA, founded in Atlanta in 1885 when organized medicine excluded Black doctors, is "a voice for those who are concerned about equal opportunity for the minority health provider and equal access to health care for all Americans," she added

The NMA, headquartered in a fully paid for new building in Washington,

D.C., has influence and visibility although Black physicians comprise only three percent of the nation's practicing physicians. U.S. Secretary of Health and Human Services Louis Sullivan, newly appointed New York Health Commissioner Woodrow Myers, Jr. and Reed Tuckson, M.D. formerly the commissioner of public health in the nation's capital, are all active NMA members.

The NMA's Annual Conand Scientific vention Assembly brings together Black and other physicians and medical researchers to exchange views on diseases adversely affecting Black people such as hypertension, diabetes, AIDS, heart disease, HIV disease, and substance abuse. Throughout the year, NMA members and officers interact with federal and local governments to provide equal access to quality health care for the poor and dispossessed.

Dr. William Matory, M.D., of Howard University medical faculty, is director of NMA's Continuing Medical Education and coordinates the Scientific Assembly.

Each national convention adopts resolutions which serve as the organization's action agenda for the ensuing year.
