Eligibility Requirements

- Student must reside in a WCBPA location; however, he or she can attend any accredited institution for higher education in the U.S.
- Student must major or minor in the subject areas, and demonstrate strong interest in journalism.
- A commitment to a three-year scholarship and internship program will be required.
- Student must maintain a 2.5 G.P.A.
- Student must demonstrate a financial need.
- Student whose application is accepted will be identified as West Coast Black Publishers/Philip Morris U.S.A. Scholar.

Selection Process

- Selection committee will review student's submission of an essay on the impact of Black media in the U.S.
- Three letters of recommendations from a college professor, community leader and employer must be submitted.
- Funds will be transferred directly to the college/university.
- Applications available at local college/university or West Coast Black Publishers Association Newspapers.

Ophir Court #201, Daughters of Isis is an auxiliary of Ophir Temple #211 of the Prince Hall Shriners, which is an auxiliary of the Ancient Egyptian Arabic Order, Nobles of the Mystic Shrine of North and South American and its Jurisdiction, Inc. The order has made significant contributions to combat illiteracy, substance abuse, unemployment and crime. Locally, their aim is to serve and support the Las Vegas Community.

Ophir Court was organized in December 1986, instituted in June of 1987 and chartered in May of 1988. Locally it supports a number of charitable organizations which include the following:

It is an on-going contributor to the Women's shelter which is a haven for battered wives.

It participated in the Bowl For Kids Sake, Big Brothers and Big Sisters on March 3, 1990. A total of \$755 was given to support this worthy cause.

It also participated in the recent Super Cities Walk-A-Thon for Multiple Sclerosis on April 1, 1990. A total of \$735 was given to aid victims and to find a cure for this neurological disease affecting millions.

On April 14, 1990 the Daughters of Isis visited the North Las Vegas Care Center. They presented an Easter Basket of candy and personal hygiene items (shaped in the form of an easter bunny) to 50 residents of the center.

The Daughters also sponsor an annual Black History Dinner Dance in February with partial proceeds being used for scholarships and other community services.

They sponsor an annual scholarship. However, this year they will be offering two \$500 scholarships to two deserving seniors from Clark County School District for the 1989-90 school year. These scholarships will be awarded at the Potentate/Commandress Ball on June 30, 1990.
